#### FIRST AMENDMENT TO CLOUD SUBSCRIPTION SERVICES AGREEMENT #2019-02-5636

#### <u>R E C I T A L S</u>

WHEREAS, County and Saba entered into that certain Agreement, dated February 1, 2019; and

WHEREAS, County and Saba desire to amend the Agreement as follows: increase the maximum contract spend from \$476,316.00 to \$\$532,134.00 and incorporate Saba Order Number 2021-1-5974 to add additional user licenses and obtain either the Cisco WebEx or Zoom connector;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

#### <u>AGREEMENT</u>

1. <u>Saba Cloud Subscription Services Agreement #2019-02-5636 Section 6. Fee and Payment</u> <u>Terms., 6.1 Fees and Payment</u> shall be amended to state that payments to Saba will not exceed **\$532,134.00** for the term of the Agreement.

2. The attached Order Number 2021-1-5974 dated to add additional Subscription services shall be incorporated into the <u>Saba Cloud Subscription Services Agreement #2019-02-5636</u> per <u>Section</u> <u>2.6 Other Services</u> and are in addition to services provided on Saba Order Q-00023479.

3. Except to the extent the Agreement is specifically amended or supplemented hereby, the Agreement, together with Exhibits is, and shall continue to be, in full force and effect as originally executed, and nothing contained herein shall, or shall be construed to modify, invalidate or otherwise affect any provision of the Agreement or any right of County arising thereunder.

4. This Amendment shall be governed by and construed under the internal laws of the state of California, and any action to enforce the terms of this Amendment or for the breach thereof shall be brought and tried in the County of Sonoma.
