

Sonoma County's Current Status (State Data)



Regional Stay-at-Home Order

- The Bay Area exited the Regional Stay at Home Order on Jan. 25
 - Restaurants and fitness centers are now allowed to operate outdoors, while personal care services such as hair and nail salons can reopen with modifications
- Sonoma County remains in the Purple Tier with associated restrictions
 - Many indoor operations remain closed


COVID-19 Deaths, by Age Group


Doses administered in Sonoma County: 45,681 (as of 2/1) (23,824 Pfizer; 21,857 Moderna)

Ethnicity of Vaccinated Individuals





Vaccine Equity Strategies

- Provide transparency in the science and vaccination process
- Prioritize those that shoulder the most risk
- Include culturally responsive practices throughout the implementation process
- Acknowledge explicitly the negative and painful history of healthcare in the US in communities of color that has led to distrust in healthcare, research, and government
- Engage community and stakeholders to better understand their concerns and needs and respond to these needs as much as possible
- Communicate effectively in culturally sensitive ways through trusted partners
- Learn and improve as we go



Vaccine Operations

- Clinics supported by the County now have capacity to provide up to 2,500 vaccinations a day for targeted groups. These sites include:
 - AMR and fire agency clinic for first responders and law enforcement at Public Health Lab
 - Sonoma County Medical Association clinic for health-care providers at Grace Pavilion/Fairgrounds
 - Safeway clinic for in-home supportive services workers at Sonoma County Fairgrounds
 - Clinical Health Appraisals clinic for Public Health field workers at County Administration building
 - DEMA Consulting clinic for community health promoters at Roseland Library
 - The Fitness Center at Santa Rosa Junior College-Petaluma Campus
 - Huerta Gym in the Town of Windsor for those ages 75 and up.
 - OptumServe site in Rohnert Park for those 75 and up
 - Sonoma Valley Veterans' Hall in Sonoma Valley
