**Resolution of the Board of Supervisors of the County of Sonoma, State of California, Amending the Allocation Lists for the County Administrator's Office and the Department of Health Services, Effective April 6, 2021, to 1) Extend the Term of 2.0 Full-Time Equivalent Time-Limited Allocations in the County Administrator's Office to Support the County's COVID-19 Response Efforts through December 31, 2021, 2) Extend the Term of 3.0 Full-Time Equivalent Time-Limited Allocations in the Department of Health Services to Support the Department's COVID-19 Response Efforts through June 30, 2022, and 3) Convert 1.0 Full-Time Equivalent Allocation From Time-Limited to Ongoing in the Department of Health Services to Support the Department's COVID-19 Response Efforts and Enhance the Department's Preparedness Program**

**Whereas**, the County Administrator has identified a need to extend the term of 2.0 full-time equivalent time-limited allocations through December 31, 2021 to continue providing strategic communications and outreach support to the COVID-19 Emergency Response and vaccine mission;

**Whereas**, the Department of Health Services has identified a need to extend the term of 3.0 full-time equivalent time-limited allocations through June 30, 2022 to support the Department's COVID-19 response efforts; and

**Whereas**, the Department has identified a need to convert to permanent a 1.0 full-time equivalent time-limited allocation to support the Department's COVID-19 response efforts and enhanced preparedness program.
