Resolution Of The Board Of Supervisors Of The County Of Sonoma, State Of California, Authorizing adjustments to increase appropriations in the FY 2020-2021 Adopted Budgets for the Public Defender's Office (PDO) and Human Services Department (HSD) by \$44,143 reflecting new funding from the Board of State and Community Corrections (BSCC) and associated expenditure for the Indigent Defense Grant Program (IDGP) effective 04/06/2021.

Whereas, the BSCC awarded the Public Defender's Office (PDO) a grant of \$882,000 for the period of February 15, 2021 through June 30, 2023; and

Whereas, PDO and the Human Services Department (HSD) have created a partnership to administer program funds for the IDGP over the aforesaid period; and

Whereas, the PDO will be allocated an estimated \$504,452of the \$882,320 total to cover payroll and administrative costs over the entire grant period; and

Whereas, HSD will be allocated an estimated \$377,868 of the \$882,320 total to cover payroll and administrative costs over the entire grant period; and

Whereas, the Board has adopted the Fiscal Year 2020-2021 Budget Resolution #20-0332 for all Governmental Entities within its jurisdiction, in accordance with Section 29088 of the Government Code of the State of California; and

Whereas, the Government Code allows for adjustments to the Adopted Budget during the 2020-2021 Fiscal Year;

Now, Therefore, Be It Resolved that the County Auditor-Controller-Treasurer-Tax Collector and
