Advisory Redistricting Commission (ARC)

- Board prescribes how members are appointed to the advisory redistricting commission
- ARC's role is to advise and assist the Board with redrawing supervisorial district boundaries
- Board decided at 2/23/21 Board meeting to have 15 commissioners, comprised of:
 - 2 appointees per supervisorial district
 - 5 at-large positions

Stipend Discussion

- Different amounts across board and commissions
- Duration of ARC meetings will vary
- Expectation of 8-12 ARC meetings throughout 2021







Outreach & Engagement

- The revised Elections Code provisions require significantly more public outreach and engagement than previous redistricting processes.
- Initial planning of English and Spanish outreach includes radio advertising, digital and print ads in local papers, social media ads, direct mail, and in-store ads or videos.
- Consultant (to be selected in the next few weeks after a competitive bidding process) will provide best practice guidance for outreach and engagement, in addition to support, training and facilitation throughout the redistricting process.







The County redistricting website is up and running and will be updated throughout the year.

Cada diez años, los gobiernos locales utilizan nuevos datos del censo para volver a trazar las líneas de sus distritos y reflejar cómo han cambiado las poblaciones locales. El Proyecto de Ley de la Asamblea 849 (2019) requiere que las ciudades y los condados involucren a las comunidades en el proceso de redistribución de distritos mediante la celebración de audiencias públicas y / o talleres y la divulgación pública, incluso a las comunidades que no hablan inglés.





Recommended Actions


- Appoint members to the 2021 Advisory Redistricting Commission;
- 2. Discussion of stipend rate and adoption of a resolution establishing a stipend for ARC members for attendance at ARC meetings;
- 3. Authorize the use of \$40,000 from contingency funds for media production and placement costs for public outreach (4/5th);
- 4. Authorize the execution of a contract for redistricting services for an estimated contract value of \$120,000
