Resolution Of The Board Of Directors Of The Sonoma County Water Agency Approving The

Urban Water Management Plan 2020

Whereas, the Urban Water Management Planning Act, which is codified at California Water Code Section 10610 et seq., requires that every urban water supplier which provides 3,000 acre feet or more of water annually, or which directly or indirectly supplies water for municipal purposes to more than 3,000 customers, shall prepare an Urban Water Management Plan, the primary objective of which is to plan for the conservation and efficient use of water; and

Whereas, the Sonoma County Water Agency (Sonoma Water) has prepared a wholesale Urban Water Management Plan (UWMP 2020) covering Sonoma Water to meet the requirements of Urban Water Management Planning Act (Act); and

Whereas, the UWMP 2020 must be adopted after public review and a public hearing by Sonoma Water's Board of Directors and must be filed with the California Department of Water Resources by July 1, 2021; and

Whereas, Sonoma Water coordinated preparation of the UWMP 2020 with other appropriate agencies in the area; provided notices to cities and counties within its service area; and encouraged the active involvement of diverse social, cultural, and economic elements of the population within the service area prior to and during the preparation of the plan as more fully described in the UWMP 2020, in compliance with the requirements of the Act; and

Whereas, on April 27, 2021, Sonoma Water circulated for public review a draft of the UWMP 2020, in compliance with the requirements of the Act; and

Whereas, a copy of the draft UWMP 2020 was made available for public inspection continuously since April 27, 2021, at Sonoma Water's Administration building, the office of the Clerk of Sonoma Water's Board of Directors, and Sonoma Water's website; and

Whereas, on May 11, 2021, this Board of Directors held a duly noticed public hearing on

the UWMP 2020, notice of the time and place of which was published in the Santa Rosa Press Democrat, a newspaper of general circulation, on April 26, 2021 and May 6, 2021; and

Whereas, Sonoma Water reviewed and considered all comments received on the draft UWMP 2020;

Now, Therefore, Be It Resolved that the Board of Directors of the Sonoma County Water Agency hereby finds, determines, and declares as follows:

- 1. All of the above recitals are true and correct.
- 2. Sonoma Water's UWMP 2020 is based upon substantial evidence, including reasonable assumptions about future conditions, and meets all requirements of the Urban Water Management Planning Act.
- 3. The Urban Water Management Plan 2020 is hereby approved and adopted.
