This Amendment Number 3 ("Amendment") is by and between the County of Sonoma, a political subdivision of the State of California (hereinafter "County"), and Senior Advocacy Services, a California non-profit Corporation, (hereinafter "Contractor").

As provided by Article 13.7., Merger, the parties hereby evidence their intent and desire to amend the Agreement. The parties mutually desire to amend said Agreement to make the following changes:

- 1. Revise Article 2., Payment, to increase the Agreement amount by Twenty-Five Thousand Six Hundred Forty-Two Dollars (\$25,642.00), for a new total of Eight Hundred Twenty-Six Thousand Three Hundred Eighty-Six Dollars (\$826,386.00); and
- Replace Section 8., Funding Allocation Summary, and the line item budgets in Section 9.1. Title III B – Ombudsman, Section 9.2. Title VII A – Ombudsman, Section 9.3. Title VII B – Elder Abuse, and Section 9.4. Ombudsman Special Deposit, in Exhibit B, Fiscal Provisions/Budgets.

RECITALS

WHEREAS, County and Contractor entered into that certain Agreement, dated July 1, 2020, for services related to the Health Insurance Counseling and Advocacy Program (HICAP), the Medicare Improvements for patients and Providers Act (MIPPA), and the Ombudsman program; and

WHEREAS, County and Contractor desire to amend the Agreement to adjust funding allocations for Ombudsman and Elder Abuse Prevention services; and

NOW, THEREFORE, the parties hereto are desirous of modifying the Agreement in accordance with the terms and conditions set forth herein and hereto agree as follows:

SPECIFIC PROVISIONS

2. <u>Payment</u>.

For all services and incidental costs required hereunder, Contractor shall be paid on a cost reimbursement basis in accordance with the budget set forth in "<u>Exhibit B: Fiscal</u> <u>Provisions/Budget</u>" (hereinafter "<u>Exhibit B</u>"), attached hereto and incorporated herein by this reference. Contractor shall be paid an amount not to exceed Eight Hundred Twenty-Six Thousand Three Hundred Eighty-Six Dollars (\$826,386.00), without the prior written

approval of County. Expenses not expressly authorized by the Agreement shall not be reimbursed.

Unless otherwise noted in this agreement, payments shall be made within the normal course of county business after presentation of an invoice in a form approved by the County for services performed. Payments shall be made only upon the satisfactory completion of the services as determined by the County.
