
Sonoma County's Daily Metrics (05/10)

Unadjusted Case Rate: 2.6 Adjusted Case Rate: 2.4 Testing Positivity (Overall): 0.9% Testing Positivity (Lowest HPI Quartile): 1.2%

- Sonoma County received 1 week credit of yellow tier metrics last week due to a case rate adjustment
- The adjusted case rate must be *below* 2 for a second consecutive week in order to qualify for the yellow tier
 - Sonoma County's adjusted case rate is higher than 2 new cases per 100,000 residents per day


Testing and Positivity

Tests per 100,000 per day, excl prisoners (7 day avg w/ 7 day lag) for Sonoma



- Testing volume of 389.9 tests per 100,000 people per day
 - State testing median=325.9
- Test positivity is less than 2% for all geographies, with the majority being under 1%

Vaccination Status of COVID-19 Cases



• The majority of cases are occurring among unvaccinated individuals


Source of Transmission

- 184 cases (Past 14 days)
 - Household transmission (27%)
 - Gatherings (22%)
 - Small and large gatherings with friends/family
 - Large work-related gatherings
 - Travel (8%)
 - 64% of these cases traveled outside California
 - Unknown (43%)

- Cases are trending younger (individuals in 20's and 30's)
- Gatherings and travel are playing a more prominent role in case transmission

Vaccine Administration

485,274 doses administered (as of 05/10)




Residents partially vaccinated: 66,208 Residents fully vaccinated: 216,086

69% of the Sonoma County population aged 16+ is at least partially vaccinated


Vaccine Providers

All Providers: Race/Ethnicity of Vaccine Recipients



County Vaccine Partners: Race/Ethnicity of Vaccine Recipients






Cumulative Dose Distribution by HPI Quartile

Three weeks ago






Least Healthy Community Conditions

Proportion of Each Age Group Vaccinated




- The majority of Sonoma County adults aged 65+ are vaccinated and test positivity among this age group is less than 1%
- COVID-19 cases are now most prevalent among the younger, less vaccinated age groups

Equity Principals & Overall Strategy

The following strategies are intended to ensure that Sonoma County's rollout of its COVID-19 vaccination program prioritizes equity in its design, process, and outcomes. The strategies are built on a foundation that at all times, and in all programmatic components, the County will:

- Provide transparency about the science of the vaccines and vaccination process;
- Prioritize those who shoulder the most risk;
- Include culturally responsive practices throughout each stage of the implementation process, (e.g. interpretation, translation, and language access, etc.);
- Through proactive communication and outreach strategies, explicitly acknowledge the negative and painful history of healthcare in communities of color that has led to distrust in healthcare, research, and government;
- Engage community members and stakeholders to better understand their concerns and needs and respond to these needs as much as possible;
- Communicate with the public effectively in culturally sensitive ways through trusted partners.
- Regularly evaluate our efforts, and learn and improve as we go.

Health Equity and the Vaccine Roll Out

- Operationalizing the first component of the equity framework.
 - i. Focuses in specific **operational strategies** for vaccine clinics, and it is broken down in five sections: Access and locations, community presence and engagement, examples of other vaccine clinic models, and staffing to ensure cultural

responsiveness.

STAFFING	Bilingual (Spanish and English)				Staff practice culturally responsive practices: look for community members who may need guidance, identify their needs and assist with registration forms, usher individuals from one station to the next. Spanish speaking staff must wear "Yo hablo Espanol" name badges.
	Multicultural Team Members				Ensure welcoming environment that represents the culture of the people being served. Strive to staff multicultural team members that share language, appearance and culture of those they serve.
	Indigenous Language Speakers				Acknowledging the needs of community members whose primary spoken language is an Indigenous Language. Ensure telephone "Language Line" services have indigenous speaking interpreters.
	Bogistration				Communicate to community members, "you will not be turned away for lack of ID, we will keep your personal information private, we do not ask for immigration status or social security number."

Vaccine Communications/Outreach Campaign

The COVID outreach/marketing campaign has been updated and refreshed with a focus on addressing vaccine hesitancy. These communications include:

- Public service announcements on Spanish & English radio
- Mobile marketing campaign targeting cell-phone users in key Census tracts
- Digital and print ads in local publications
- Banners for vaccine clinics and public events such as health fairs
- Communications materials to support existing outreach efforts including vaccination clinics organized in partnership with trusted community-based organizations.

- Began Receiving Applications through the Application Portal on April 19, 2021
- The project is being implemented in partnership with 10 Community Based Organizations (CBOs)
- Total Received: \$32 million
- Total Disbursed: \$1,964,820
- Applications Processed:
 - Tenants: 572 Applications
 - Landlord: 313 Applications
