Resolution of the Board of Supervisors of the County of Sonoma, State of California, Adopting Amended Rates to Recover the Reasonable Cost of Providing Behavioral Health Services

Whereas, the Board of Supervisors is authorized by Welfare and Institutions Code section 5709 to establish rates to recover the reasonable cost of providing certain health services.

Now, Therefore, Be It Resolved that to recover the reasonable cost of providing certain health services, it is necessary to increase certain rates and establish certain new rates as set forth below.

Be It Further Resolved, based on information presented to this Board, this Board finds that the proposed rates comply with all legal requirements, including Art. XIII C of the California Constitution.

Be It Further Resolved that if any section, subsection, sentence, clause or phrase of this resolution is for any reason held to be unconstitutional or otherwise invalid, such decision shall not affect the validity of the remaining portion of this resolution.
