Strategic Plan Board Liaison Role

Support Year 1 Strategic Plan implementation

- Provide input on outcomes and measures for objectives in Plan pillar
- Provide input on implementation phasing and priority and priority projects to achieve outcomes
- Provide input on city and community partner engagement
- Attend Strategic Plan pillar meetings in August and December (4 hours total for each Supervisor. 2, one-hour meetings for each pillar.)

Hazard Mitigation Grant Program Recent Awards

- 5/18/2021 Phase 1 Hazardous Fuels Reduction Treatment (Permit Sonoma)
 - Phase 1 Project total \$1.4 million
 - Total project is \$6 million if later stages approved
 - Phase 1 Outreach, inspection and design
- 2/1/2021- Data Center Generator Phase 2 (Information Systems Department)
 - Phase 2 project total is \$658,000
 - Completes project
- 1/21/2021 Geyserville Drainage Feasibility Plan (Transportation and public works)
 - Project Total \$167,000

Adopted Budget Overview: Budgetary Changes

Departmental Items

- Supplemental Changes: \$148M increased revenues/\$108M increased expenditures
- Add Backs: \$2.2M in one-time items; \$1.7M in on-going items
- Program Change Requests: \$3.6M in 21 items; all self-funded



Adopted Budget Overview: Budgetary Changes

Budget Deliberation Items (Exhibit A of the Budget Resolution)

<u>On-going Items</u>

- \$1.8M to retain positions funded short term with PG&E funds
- \$1.5M Fire Services funding to support specified consolidations
- \$1.1M reserved on-going capacity



Adopted Budget Overview: Budgetary Changes

Budget Deliberation Items (Exhibit A of the Budget Resolution) One-Time Items

- \$3.0M to create a disaster response fund
- \$2.5M for hazardous tree removal
- \$2.2M for FEMA audit reserve
- \$2.0M Fire Services funding
- \$2.0M for homeless services support
- \$2.0M for FY21-22 contingencies
- \$500k for LED monument signs at fire stations
- \$350k to support Chambers of Commerce & Visitor Centers
- \$350k for septic infrastructure mapping
- \$140k for archives at Los Guilicos
- \$ 30k for radio station antenna construction



Adopted Budget Overview: Position Changes

Exhibit D of the Budget Resolution

- Supplemental Changes: 22.95 FTEs
 - $_{\odot}$ Administrative changes to allocations under HR's delegated authority
 - Board items adding or changing from March 3-June 8
 - $_{\odot}$ Extension of 3.0 time limited positions associated with COVID response $_{\odot}$ 0.5 LAFCO addition
- Board Hearing Actions: 26.75 FTEs
 12 month vacancy sweeps: -3.0 FTEs
 Add Backs: 10 FTEs
 PCRs: 19.75 FTEs



Board Actions

- Adopt Concurrent Resolutions establishing FY 2020-21 and 2021-22 appropriations limits for the County and Board of Supervisors-governed special districts and County Service Areas
- Adopt the FY 2021-22 Annual Capital Projects List as specified in Supplemental Budget Adjustments
- Authorize Human Resources Department and Departments to administer layoff proceedings and to implement strategies to mitigate layoffs
- Assign Board liaisons to Strategic Plan pillars
