Resolution of the Board of Supervisors, County of Sonoma, State of California, Congratulating Logan Harvey for his years of Public Service as

Mayor of the City of Sonoma

WHEREAS, a native of Sonoma Valley, Logan was elected to the City Council in November 2018 and served the first year as Vice Mayor and became City Mayor in December 2019 making him the youngest Mayor in Sonoma's history where he dedicated his focus and efforts to climate change, housing and equity issues; and

WHEREAS, Logan completed elementary, middle and high School education in Sonoma Valley and attended and graduated Santa Rosa Junior College and San Francisco State where he received a degree in English education and ended up teaching English in South Korea for three years after graduating; and

WHEREAS, some of his greatest accomplishments with the City of Sonoma include passing Sonoma's minimum wage ordinance fifty cents higher than the state's minimum wage, developing an affordable housing trust fund, creating an ordinance to allow the opening of Sonoma's first dispensary, and safely managing PG&E's public safety power shutoff all in the same year; and

WHEREAS, Logan's commitment was instrumental in the adjusted inclusionary ordinance to increase the amount of low-income affordable housing required in new rental developments adding a middle class affordable housing bracket to allow working families the opportunity to buy new housing without competing against higher-net-worth second home buyers, making the groundbreaking ceremony of 48 new affordable housing units in the City of Sonoma one of the single most important events in his professional life; and

WHEREAS, in response to the COVID-19 pandemic as City Mayor, Logan developed and lead a COVID-19 task force made up of local nonprofits and community leaders to ensure all Sonoma

Valley residents; especially underserved and latinx communities had access to food, testing, vaccines and other resources; and

WHEREAS, while serving as City Mayor Logan also worked as a Zero Waste Specialist with Sonoma-Marin Recology where he became an outspoken voice among young leaders in the region on issues of affordability and environmental sustainability; and

WHEREAS, since January 2019 Logan served as Vice Chair of the Sonoma County Transportation Authority/Regional Climate Protection Authority, where he provided policy direction and oversight over Measure M funds and was instrumental in the framing of the measure which will provide additional funding for public transit and bicycles as well as potholes and roads; and

Date: July 13, 2021 Page 2 WHEREAS, other professional achievements include collaboration and strategic planning with the County of Sonoma to end Homelessness in Sonoma Valley and self-managing a campaign and winning against seven other candidates, including beating an incumbent in total votes; and WHEREAS, supportive of a County and City collaboration, Logan became a resource and advocate for the Community frequently attending the Springs Municipal Advisory Council and El Verano Community meetings; and WHEREAS, often spotted riding his bicycle around town and on a rare occasion saving a duck, Logan is a person with unique political skills, enthusiasm, creativity, and heart, who leads by example and with the community in mind, a community who will miss him and his wife Lili when they embark on their journey to Seattle, Washington where he will take a position with Recology King County. **NOW, THEREFORE, BE IT RESOLVED**, that the Board of Supervisors of the County of Sonoma do hereby Congratulate Logan Harvey for his years in public service as Mayor of the City of Sonoma. **Supervisors:** Hopkins: Gorin: Rabbitt: Coursey: Gore: Ayes: Noes: Abstain: Absent: So Ordered.
