Resolution Of The Board Of Supervisors Of The County Of Sonoma, State Of California,

Authorizing the Director of the Human Services Department (HSD) to modify its FY 2021-2022

HSD Budget to increase appropriations in the amount of \$256,580 to reflect new funding

from the California Department of Aging (CDA) and California Community Care Transitions

(CCT) effective 7/13/2021.

Whereas, the Sonoma County Area Agency on Aging and Disability Services & Legal Center were designated as an Emerging Aging and Disability Resource Connection (ADRC) by the California Department of Aging (CDA); and

Whereas, the CDA has allocated \$196,863 to the Sonoma County Area Agency on Aging for FY 2021-2022 as the fiscal lead in partnership with Disability Services & Legal Center; and

Whereas, the Human Services Department (HSD) anticipates projected California Community Care Transitions (CCT) revenue of \$79,500 in FY 2021-2022 as a new CCT Provider approved by the California Department of Health Care Services; and

**Whereas,** increased appropriations of \$256,580 from the CDA and CCT will be added to the current FY 2021-2022 budget in order to provide additional services to older adults and people with disabilities in Sonoma County; and

Whereas, CDA funding of at least \$196,863 is expected for subsequent fiscal years; and

Whereas, CCT revenue of at least \$79,500 is expected for subsequent fiscal years; and

Whereas, \$19,783 of the CDA funding will be used to pay for 13.5% of a Program Planning and Evaluation Analyst's (PPEA) payroll cost to administer and oversee the ADRC program; and

Whereas, Section 29088 and 29125 of the Government Code of the State of California, allows for adjustments to the Final Budget during the 2021-2022 Fiscal Year;

**Now, Therefore, Be It Resolved** that the County Auditor-Controller-Treasurer-Tax Collector and the County Administrator are hereby authorized and directed to complete the budgetary and accounting transfers and adjustments to the HSD Fiscal Year 2021-2022 budget as follows:
