One-Year Plan for CDBG/HOME/ESG – FY 2021-22

- A One-Year Action Plan is:
 - Based on the 5-year Consolidated Plan (adopted June 2020)
 - A map for expenditures for FY 2021-22 from CDBG/HOME and ESG
 - Based on community input/participation & committee review
- Reflects CDBG/HOME funding for the <u>Urban County</u>:
 - Unincorporated areas plus ...
 - Seven non-entitlement cities: Cloverdale, Cotati, Healdsburg, Rohnert Park, Sebastopol, Sonoma, and the Town of Windsor.
 - Not Santa Rosa and Petaluma (SR and Petaluma get own allocations)*

* except for \$\$ for services that benefit the entire county without regard to residence



Review Process

- Notice of Funding Availability:
 - Released May 10, 2021
 - Applications Due on June 11, 2021
- Staff Review of Applications June 12 25, 2021
- Meetings and Workshops including the Cities and Towns Advisory Committee and Community Development Committee June 16, 2021 and June 29, 2021
- Public Comment Period for One-Year Plan July 9 August 7, 2021
- Public Hearing of CTAC/CD Committee July 21, 2021 (voted to approve One-Year Plan)
- Board of Supervisors/CDC July 27, 2021 (done within Public Comment Period)
- Compile remaining public comments and Submit One-Year Action plan to HUD on or before August 16, 2021

Proposed Awards – HOME

- \$619,053 Available
 - Recommend \$82,488 for Award
 - \$535,565 remaining unallocated
 - (can be rolled into next year, amended in current year with substantial amendment)
- NOTE: HOME funds come with income restricted rents

Two Key Issues This Time (Issue #1)

- If CDBG Urban County funds for Affordable Housing can generally only primarily benefit the unincorporated area + seven cities, then:
 - Three applications were/are ineligible
 - More specific information from HUD came later in the review process
- PEP Housing's concerns:
 - Says that HUD limitation should have been made more clear in the May 10, 2021 NOFA
 - Says that 5 of the Linda Tunis Project's 25 units' link to Coordinated Entry makes part of the LT project a countywide homeless service and therefore eligible for these funds.
 - Says that staff did not provide staff reports/recommendations in a timely manner, did not read PEP's comments into the record.



Two Key Issues This Time (Issue #2)

- We're asking the Board/CDC to approve the Plan *within* the Public Comment period, not at its end (preferable). Why?
 - Board meets again 8-17, but
 - One-Year Plan is due to HUD 8-16
 - OK from HUD to do this, but staff needs to incorporate any additional public comment into the record.



Recommendation

- Staff recommends that the Board adopt the One-Year Plan, authorize staff to submit Plan to HUD in time for 8-16-2021; and if desired:
 - a) Direct staff to not award infrastructure/accessibility funds before 9-30-2021; so that
 - b) If HUD has a reinterpretation by 9-30-2021, direct CTAC/CD Committee to meet again and return to the Board with new recommendations to be processed via a Plan Amendment); or
 - c) If there is no HUD reinterpretation by 9-30-2021, direct staff to release the funds to the recommended projects starting 10-1-2021; and
 - d) Direct staff to include further public comment before August 9, 2021.



Alternatively

- 2. Adopt the One-Year Plan as-is, direct staff to include further public comment and file by 8-16-2021
- 3. Change allocations today (some risk of a later more formal HUD determination)
- 4. Direct staff to look for other sources of funds for the ineligible project(s).
