Resolution Of The Board Of Supervisors Of The County Of Sonoma, State Of California, to authorize the Director of the Human Services Department to execute Standard Agreement #SP-2122-27 with the California Department of Aging for Federal Fiscal Year 2021/2022 in the amount of \$94,018 and authorize the Director of the Human Services Department to execute future agreement amendments to adjust for revenue changes.

Whereas, the Sonoma County Area Agency on Aging is designated by the California Department of Aging; and

Whereas, the CalFresh Healthy Living program is known on the federal level as the Supplemental Nutrition Assistance Program Education (SNAP-Ed); and

Whereas, the CalFresh Healthy Living program operates on the federal fiscal year (FFY) from October 1, 2021 through September 30, 2022, requiring the total grant allocation amount of \$94,018 to be divided into two allotments for receipt by the County of Sonoma in FY 2021-22 and FY 2022-23; and

Whereas, a 75%-25% split will be applied to the total FFY grant amount such that the first allotment of \$70,514 will be received by the County of Sonoma in FY 2021-22, and the second allotment of \$23,504 will be received in FY 2022-23; and

Whereas, standard agreements must be executed with the State before funds become available for Sonoma County; and

Whereas, the Board has adopted the FY 2021-22 Budget for all governmental entities;

Whereas, the Government Code allows for adjustments to the Adopted Budget during the 2021-22 Fiscal Year;

Now, Therefore, Be It Resolved that the Board of Supervisors of the County of Sonoma authorizes the Director of the Human Services Department to execute Standard Agreement #SP-2122-27 in the amount of \$94,018 with the California Department of Aging for FFY 2021-2022 and authorizes the Director of the Human Services Department to execute future agreement amendments to adjust for revenue changes.
