August 12		Census Bureau released 2020 Census data (in legacy format).
September 20		Official California Redistricting data released September 20. All state prison incarcerated persons are counted only at their last known place of residence.
		The board and employees or contractors of the county shall not release draft maps of supervisorial districts earlier than one weeks after the Official California Redistricting data is first made publicly available
October 5	BOS	Second Official Hearing to review 2020 data and existing districts for population balance; to receive public input on communities of interest and other community mapping priorities

Redistricting Rules and Goals

- **Equal Population**
- Federal Voting Rights Act
- No Racial Gerrymandering



2. California Criteria for Counties

- Geographically contiguous
- 2. Undivided neighborhoods and "communities of interest"

(Socio-economic geographic areas that should be kept together)

- 3. Cities and censusdesignated places (CDP)
- 4. Easily identifiable boundaries
- 5. Compact

 (Do not bypass one group of people to get to a more distant group of people)

Prohibited:

1.

"Shall not favor or discriminate against a political party."

3. Other Traditional Redistricting Principles

- Minimize voters shifted to different election years
- Respect voters' choices / continuity in office
- **Future population growth**
- Preserving the core of existing districts

1st Question: what defines your community?

2nd Question:

Would this community benefit from being "included within a single district for purposes of its effective and fair representation"?

• Or would it benefit more from having multiple representatives?

Public Mapping and Map Review Tools

<u>Draw a Map</u>

Different tools for different purposes and levels of technical interest

- <u>Story Map</u>, an interactive way to view community demographics and data for identifying communities of interest.
- Online Interactive Review Map, a simple map review tool
- Paper "Public Participation Kit with Population Counts" for those who do not want to use a computer
- Paper "Public Participation Kit with Population Unit IDs" an Excelbased simple "draw a draft map" tools
- **"DistrictR"**, an easy-to-use paint brush map drawing tool
- Caliper Maptitude Online Redistricting, a powerful, data-rich "draw a draft map" online mapping tool

Funding the Redistricting Effort



- Your Board has approved \$243,800 in contingency funding
- The full amount will be fully expended by the end of the project, with the following primary expenditure categories:
 - Consultants (more on next slide)
 - Translation/interpretation services
 - Outreach materials, print production, placement costs
 - Commissioner stipends
- Original cost estimates have increased based on commissioner requests for additional meetings, facilitator, and establishment of ad hocs
 - Possibility of overages (e.g., stipends, translation / interpretation, contracts)

Contracts



- Redistricting Consultant: NDC
 - NDC selected after a competitive bid process to help the County with the redistricting process
 - Contract not exceed \$120,000
- Facilitator: **Dr. Rosa Perez**
 - Facilitator for 8/23/21 ARC meeting on equity
 - Will provide a summary report memorializing the historical context provided by the guest panel
 - Contract not to exceed \$10,000
- Community engagement Herman G. Hernandez
 - Selected for his position as locally known and trusted community leader
 - Contract not to exceed \$35,000

Community Engagement

- SONOMA 2021 COUNTY REDISTRICTING
- Herman G. Hernandez is assisting the County with seeking and collecting input from underrepresented communities, including Latinx, Asian, Black, and Native communities
- Engagement plan includes the following elements:
 - In-person/virtual community meeting presentations
 - Virtual map presentations / listening sessions
 - Focus groups
 - Outdoor park mapping events
- The County enlisted Mr. Hernandez so that input could be collected leading up to the October 15th deadline to provide input for <u>draft</u> maps

"A local jurisdiction <u>may</u> establish by resolution...an advisory redistricting commission..." CA Elections Code, Section 23000

- Advisory Redistricting Commission
 - Recommends placement of district boundaries to a legislative body
- Hybrid Redistricting Commission
 - Recommends two or more maps for placement of district boundaries to a legislative body
- Independent Redistricting Commission
 - A non-legislative body that is empowered to adopt the district boundaries of a legislative body



County Redistricting Commissions



2011

- Supervisorial Redistricting Advisory Committee
- District Attorney, Sheriff, Clerk-Recorder-Assessor
- 3 public meetings

2021

- Advisory Redistricting Commission
- 19 (now 18) appointed members of the public
 - District 1: 3
 - District 2: 3
 - District 3: 6
 - District 4: 3
 - District 5: 4 (now 3)
- 14 public meetings
 - 7 commission meetings
 - 5 BOS meetings
 - 1 special training session
 - 1 town hall

The ARC commissioners were appointed at the June 8, 2021 and July 20, 2021 Board meetings.

- Engagement Ad Hoc
 - Four commissioners
 - Focused on how best to reach underrepresented communities
 - Suggested hiring local engagement consultant
 - Providing input and support as needed to Mr. Hernandez
- Equity Ad Hoc
 - Five commissioners
 - Drafted set of equity principles for the ARC's consideration
 - Requested and suggested panelists to provide local historical context at the ARC's 9/13/21 equity meeting
 - Requested a facilitator and suggested Dr. Rosa Perez as facilitator of 9/13 meeting
 - Dr. Perez will document the historical context provided by the guest panel for future County efforts
