A series of consecutive storm events over the past 14 days have dropped significant amounts of precipitation in the Sonoma County operational area and continued heavy rains have caused severe ground saturation that has not had time to dissipate. These storm events have resulted in major flooding in parts of Sonoma County. The current storm conditions have caused the Russian River to rise at an alarming rate and, based on best available current information, the river is now projected to

crest sometime overnight at more than 14 feet above flood stage near Guerneville.

Flooding is also expected along the upper Russian River near Healdsburg and Geyserville. The Board voted to add the item to the agenda with a unanimous vote.
