The Board of Supervisors, the Board of Directors of Sonoma Water Agency and the Board of the Sonoma Valley County Sanitation District authorized finalization and execution of a settlement in which the property owner Judith Brown will remain responsible for the environmental clean up cost of the contamination plume at 18460 Hwy 12 in Boyes Hot Springs. Sonoma Valley County Sanitation District and Sonoma Water will pay plaintiff \$1,000,000.00. The 1,000,000.00 will be funded as follows: \$700,000.00 of the settlement will be paid by the insurers for the County of Sonoma, Sonoma Water and Sonoma Valley County Sanitation District, \$100,000.00 will be paid by Ed Clark and Assoc., and \$200,000.00 will be paid by Sonoma Valley County Sanitation District. Plaintiff and Defendants will release each other from claims about this contamination plume the lawsuit that seeks to force the Regional Water Quality Control Board to name the County of Sonoma Water and Sonoma Valley County Sanitation District as responsible parties for the clean up will be dismissed. The Board of Supervisors, the Board of Directors of Sonoma Water Agency and the Board of the Sonoma Valley County Sanitation District further authorize finalization and execution of a settlement with the insurers of the case in which they will fund the settlement in exchange for the release of liability.
