Recommended Action:

Authorize Sonoma County Water Agency's General Manager on behalf of Sonoma County Water Agency and County Sanitation Districts to execute the First Amended Agreement for As-Needed Regulatory and Permitting Assistance with Larry Walker Associates, Inc., to provide regulatory and permitting assistance in a form approved by County Counsel. The amended agreement updates Exhibit C, Schedule of Costs, with no change to agreement total of \$300,000 and no change to end date of June 30, 2024.

Executive Summary:

Sonoma County Water Agency, Occidental County Sanitation District, Russian River County Sanitation District, Sonoma Valley County Sanitation District, and South Park County Sanitation District (collectively referred to as Sonoma Water) needs an experienced consultant to assist with the development and negotiations of National Pollutant Discharge Elimination System (NPDES) and Waste Discharge Requirements (WDR) Permits issued by the Regional Water Quality Control Boards, in Region 1 and Region 2. The assistance includes but is not limited to:

1. Completing Reports of Waste Discharge for various facilities,
2. Reviewing and negotiating permits,
3. Analyzing data (including Reasonable Potential Analysis),

4. Performing water quality studies (e.g. Metals Translator),
5. Performing water reuse studies, and
6. Providing pollution prevention expertise.

The First Amended Agreement will increase rates, by an average of 4-percent annually, to align with Larry Walker Associates Inc.'s, (Consultant) current rates. The consultant has indicated that all work under the agreement can be completed with no change to the agreement total of \$300,000.

Discussion:

HISTORY OF ITEM/BACKGROUND

Sonoma County Water Agency operates and manages Occidental County Sanitation District, Russian River County Sanitation District, Sonoma Valley County Sanitation District, and South Park County Sanitation District ("Districts") under contract with Districts, as well as Airport/Larkfield/Wikiup Sanitation Zone, Geyserville Sanitation Zone, Pengrove Sanitation Zone, and Sea Ranch Sanitation Zone ("Zones"). The services of a consultant are needed to support operations and the permitting process.

Sonoma Water and Consultant entered into an agreement for regulatory and permitting assistance, dated August 5, 2020, in the amount of \$300,000.

Consultant is continuing to assist with the development and negotiations of NPDES and WDR permits on an as-needed basis.

SELECTION PROCESS

On October 20, 2017, Sonoma Water issued a Request for Statements of Qualifications to the following 15 firms:

Statements of Qualifications were evaluated based on thoroughness of response, professional qualifications and demonstrated ability to perform the work, and exceptions to standard terms in the sample agreement. Based on the evaluations, all respondents were selected for the list of qualified consultants.

Consultant was selected for the agreement because of its extensive experience in NPDES and WDR permitting. Consultant is currently assisting other agencies in Regional Water Quality Control Boards in Region 1 and Region 2 with NPDES and WDR permit requirements.

SERVICES TO BE PERFORMED

Under the proposed amended agreement, Consultant will communicate with Regional Water Quality Control Board staff, review and prepare comments on draft permits and tentative orders, assist with NPDES permit implementation, provide updates on water quality regulations and policies, participate in stakeholder advisory groups and support policy development efforts, provide technical advice for agricultural irrigation impoundments pilot project (AB 1200), and other tasks as requested by Sonoma Water.

Amending the agreement is necessary to update Exhibit C, Schedule of Costs, to increase rates to be aligned with Consultant's current rates, with no change to agreement total of \$300,000 and no change to end date of June 30, 2024.

- 08/04/2020: Approved agreement between Sonoma Water and Larry Walker Associates, Inc., for regulatory and permitting assistance. Cost \$300,000, term end June 30, 2024.
- 12/10/2013: Approved agreement between Russian River County Sanitation District and Larry Walker Associates, Inc., for regulatory and permitting assistance. Cost \$250,000; term end December 31, 2018.
- 10/22/2013: Approved agreement between Sonoma Valley County Sanitation District and Larry Walker Associates, Inc., for regulatory and permitting assistance. Cost \$491,665; term end December 31, 2018.
- 04/09/2013: Approved agreement between Occidental County Sanitation District and Larry Walker Associates, Inc., for regulatory assistance services for discharge and permit requirements. Cost \$100,000; term end June 30, 2017.
- 10/25/2011: Approved agreement between Sonoma County Water Agency and Larry Walker Associates, Inc., for regulatory assistance services for discharge and permit requirements for

Airport/Larkfield/Wikiup Sanitation Zone. Cost \$75,000; term end December 31, 2012.
