### Title:

Continued Participation in Clipper START Regional Means-Based Transit Fare Program

### Recommended Action:

Adopt a Resolution approving Sonoma County Transit's continued participation in the Metropolitan Transportation Commission's Regional Means-Based Transit Fare Program (Clipper START Extended Pilot Program) through June 30, 2023.

### Executive Summary:

The Department of Transportation and Public Works is requesting adoption of a Resolution for Sonoma County Transit to continue participating in the Regional Means-Based Transit Fare Program established by the Metropolitan Transportation Commission (MTC). The Regional Means-Based Transit Fare Program, branded as Clipper START, is a pilot program that seeks to improve affordability for adult transit passengers who earn a lower income. Originally, the program was to end on December 31, 2021. However, MTC recommends extending the pilot period until June 30, 2023 due to the effects of the pandemic on overall transit ridership and program participation. MTC will continue to provide funding from the Regional Means-Based Transit Fare Program to subsidize adult fare discounts offered during the Clipper START pilot program.

### Discussion:

The Clipper START program is the first regional means-based transit fare program in the Bay Area. Launched by MTC in July 2020, the program offers a discount on single-ride transit fares for eligible adults who earn under 200 percent of the federal poverty level. Currently, there are 15 bay area transit operators who participate in the program, including Sonoma County Transit.

In response to COVID-19, MTC has recommended that participants extend the Pilot Program until June 30, 2023 to better gauge the level of participation by eligible passengers as Bay Area transit systems continue their recovery from the effects of the pandemic.

As a participant in the Clipper START Pilot Program, Sonoma County Transit offers a 20% per trip discount off its regular adult fare. After providing proof of identity and proof of income, eligible adults receive a personalized Clipper card that can be used for single-ride discounts on all participating transit systems.

MTC is providing funds to participating transit operators to help subsidize Clipper START fare discounts offered during the pilot period.
