Executive Summary:

This item requests adoption of a resolution to recognize and express gratitude to Steve Herron for over 22 years of service supporting Sonoma County adult and youth workforce programs.

Discussion:

Steve Herron began serving on the Sonoma County Workforce Investment Board (WIB) and the WIB Executive Committee in 2000. The WIB is a group of key stakeholders appointed by the Sonoma County Board of Supervisors to address workforce challenges throughout the county. WIB members are leaders in the community who represent business, industry, labor, education, and economic development. Their vision is to create a robust local workforce with the skills needed for today and for tomorrow.
