- D) Approve the appointment of Michael Mueller to the Historical Records Commission for a term beginning July 12, 2022 and ending on July 11, 2026.

Executive Summary:

item submits recommendations for positions on the Agricultural Preservation and Open Space Fiscal Oversight Commission, the Aviation Commission, the Great Redwood Trail Agency, and the Historical Records Commission.

Discussion:

The Agricultural Preservation and Open Space Fiscal Oversight Commission, also referred to as the Fiscal Oversight Commission, serves as an audit committee and is responsible for reviewing each proposed acquisition or conveyance of interest in real property, previewing any borrowing transaction for compliance, and reviewing the annual audit. It can also review internal financial records of the Open Space Special Tax Account, operations and maintenance, and procurement practices.

The Aviation Commission conducts public meetings to provide an opportunity for public input on Airport-related matters, serves as a liaison between Airport tenants and stakeholders and Airport staff, reviews aviation matters related to the operation of the Airport, and provides recommendations, advice, and support to Airport staff

The Great Redwood Trail is a 320-mile, world-class, multi-use rail-to-trail project connecting California's San Francisco and Humboldt Bays. The legacy trail will travel through some of the wildest and most scenic landscapes in the United States, traversing old growth redwood forests, running alongside oak woodlands and vineyards, and winding through the magnificent Eel River Canyon.
