### Title:

Response to the 2021-22 Civil Grand Jury Report

### Recommended Action:

Approve the Board of Supervisors response to the 2021-22 Civil Grand Jury Report recommendations, and direct staff to formally transmit Sonoma County's complete set of responses to the 2021-22 Civil Grand Jury Report findings and recommendations.

### Executive Summary:

Each year the Civil Grand Jury completes a Final Report on its investigations of potential issues in local government agencies. The 2021-22 Grand Jury Final Report was presented to the Presiding Judge of the Superior Court on June 20, 2022. The Final Report included various findings and recommendations that require response from the Board of Supervisors within 90 days, or no later than September 18, 2022. Once approved, the full set of responses to the 2021-22 Civil Grand Jury Report will be transmitted to the Presiding Judge of the Superior Court.

### Discussion:

Under California Law, Civil Grand Jury's exercise oversight of local government agencies, including counties, cities, and special districts. They do so by investigating issues that are either brought to their attention through citizen complaints or are selected by the Grand Jury members and issuing reports on their findings and recommendations.

The 2021-22 Grand Jury Final Report was presented to the Presiding Judge of the Superior Court on June 20, 2020. The Final Report included various findings and recommendations that require response from the Board of Supervisors within 90 days, or no later than September 18, 2022. Once approved, the full set of responses to the 2021-22 Civil Grand Jury Report will be transmitted to the Presiding Judge of the Superior Court.
