Approve the appointment of Devanshi Unadkat. Dr. Devanshi Unadkat is an assistant professor in the school of education at the University of San Francisco. Dr. Unadkat began her career in an early childhood education setting that valued interdisciplinary early childhood perspectives and emphasized innovative, anti-settings
